RESOLUTION NO. 16-001 - RESOLUTION 3 4 AUTHORIZING THE EXECUTIVE DIRECTOR TO NEGOTIATE 5 AN AGREEMENT WITH LOTUS EQUITY GROUP, LLC FOR THE 6 PURCHASE OF BEARS & EAGLES RIVERFRONT STADIUM.) 7 8 CHAIRMAN KLINGHOFFER: Then we -- we have 9 one Resolution on the agenda regarding the 10 acceptance of a proposal from the Lotus Equity 11 Group to purchase Bears and Eagles Riverfront 12 Stadium. 13 Do we have someone moving this? 14 COMMISSIONER BROWN: I'll move it. 15 MS. DILLON: Who was that? 16 COMMISSIONER BROWN: Commissioner Brown. 17 MS. DILLON: Thank you. 18 COMMISSIONER DUNEC: Mark Dunec will 19 second. 20 MS. DILLON: Thank you. 21 MS. 1 COMMISSIONER SPIESBACH: -- my --2 This is Commissioner Spiesbach. 3 -- my only question --4 CHAIRMAN KLINGHOFFER: Yeah. 5 COMMISSIONER SPIESBACH: -- would be we're 6 meeting on Tuesday, are we -- I'm just --7 MR. ROTHER: Yeah. 8 COMMISSIONER SPIESBACH: -- not quite clear 9 why we needed a Special and this --10 MR. ROTHER: Let me tell you why --11 COMMISSIONER SPIESBACH: -- added to the 12 agenda. 13 MR. ROTHER: The -- the -- part of the negotiations that took place with the committee 14 15 and the various parties was the speed by which 16 this could be done. 17 One of the things that Lotus specifically 18 made a point of that it could move this to the --19 the point of a contract within 30 days. 20 And the County Executive asked us to 21 expedite this in every way possible because he 22 wanted to have that -- that contract finalized as 23 quickly as possible. And so he asked us if we 24 could expedite this and I told him we would see 25 if we could have a Special Meeting in order to do

1 that.

2 And that's -- that's the only reason. 3 We are going to be getting on the phone as 4 we conclude this meeting with the Lotus people 5 and some of the professionals that we've hired in 6 the past with regard to the facility, so that 7 during that 30 day period they can do whatever 8 due diligence they need to do and, in that 9 fashion, also expedite it. 10 So we are simply responding to the County 11 Executive's urging to move this as rapidly as 12 possible. 13 COMMISSIONER SPIESBACH: Thank you for the 14 explanation. 15 CHAIRMAN KLINGHOFFER: Just to -- just to

16 clarify one point.

17 This is a, as I -- as I read it, a resolution to authorize you to negotiate. 18 19 Presumably the contract will come back to the 20 Board for final approval. 21 MR. ROTHER: Precisely. Precisely. 22 CHAIRMAN KLINGHOFFER: Okay. 23 MR. ROTHER: That's exactly what will 24 happen. 25 CHAIRMAN KLINGHOFFER: Okay.
